

**Precious Blood Kindergarten (Sham Shui Po) Precious Blood Nursery  
Information on Admission to Nursery (K1) and Pre-nursery (N1) Classes  
in the 2022-2023 school year**

**Application Methods:**

1. Apply online (A confirmation will be sent to your email account after receiving your online application.)  
\* Please add "info@pbn.edu.hk" to your Whitelist or Safe Senders list to prevent the system from deleting the confirmation email or moving it to the junk box.
2. Download the application form from the school website
3. Collect and submit the application form in person

**Interview Arrangements:**

1. A parent should accompany their child for the interview.
2. The interview will last for about 30 to 45 minutes.
3. If translation service is needed for non-Chinese speaking applicants, please contact the school in advance so that the school can make special arrangements accordingly. Chinese-speaking family members or friends are welcome to accompany the applicants during the interview for translation.
4. All applicants will be invited to an interview.
5. If the applicant is absent on the date of interview (either sick or personal issues), we will not arrange another interview and according to the guidelines from the Education Bureau (EDB), all application fees are non-refundable.
6. Due to a large number of candidates, request for change of time will not be entertained.

7. In response to COVID-19, the school may make changes to the interview in order to protect the health of the children and parents. In case of any changes, parents will receive notification via mail or email by the end of October.
8. Personal data being collected will be used for application purpose only. Data of unsuccessful applicants will be discarded.

#### **Admission Criteria:**

1. Performance in the interview
2. Higher priority will be granted to applicants with siblings who are our current students
3. The applicants from families in need will be given due priority consideration when applying for whole-day classes (Due to the limited number of school places, not all applicants fulfilling the priority consideration will be admitted.)

#### **Registration Arrangements:**

1. Successful K1 applicants: Parents should complete the registration procedures for their child from 6 to 8 January 2022 (“Centralised Registration Dates”) by submitting the original Registration Certificate (“2022/23 RC”), other required documents and registration fee.
2. Successful half-day and whole-day Pre-nursery applicants: Parents should complete the registration procedures for their child from 12 to 14 January 2022 by submitting the required documents and registration fee.
3. The registration fee for 2022/23 half-day K1 place is HK\$970 and that for whole-day pre-nursery is HK\$1,570. The registration fee will be refunded to the parents in September. Should parents decide to change school after registration, please notify the Kindergarten in writing. The Kindergarten will return the “2022/23 RC” but the registration fee will not be refunded. Upon obtaining the “2022/23 RC”, the Kindergarten will no longer reserve the school place for the child.
4. Please be reminded that if parents cannot submit the valid registration documents during the registration period, the Kindergarten may not be able to complete the registration for their child. Hence, parents are required to submit application for the relevant registration documents to the EDB within the specified period.

#### **Application for the “Registration Certificate for Kindergarten Admission”**

1. Under the Kindergarten Education Scheme (“Scheme”), each child who can receive education in Hong Kong will only be issued a registration document and all Scheme-kindergartens can only admit children holding a valid registration document.
2. Parents are required to submit an application for the “Registration Certificate for Kindergarten Admission” (“RC”) to the EDB from September to November 2021. The “RC” will be open for applications in September 2021 and the EDB will announce and upload the details of application onto the EDB’s website (<https://www.edb.gov.hk/en/edu-system/preprimary-kindergarten/kindergarten-k1-admission-arrangements/front.html>) in due course.
